The Prison Rape Elimination Act (PREA) is federal legislation enacted in 2003 and finalized in 2012. It contains numerous requirements for adult and juvenile custodial facilities across the United States. The Kern County Sheriff's Office (KCSO) recognizes our responsibility to all inmates detained in our facilities, their families, and the community we serve to embrace the PREA legislation and its safety standards. To that end, KCSO has established and maintained a dedicated PREA compliance team with sufficient management and supervisory authority to ensure compliance with the PREA standards.

In 2013, KCSO committed to achieving agency certification of compliance with the PREA standards. This process began with development of specific policies and procedures, training for all personnel, and a review of the physical plant of each facility. Agency training, practices, and policies are routinely evaluated to ensure effectiveness and that they meet the current standard. Our goal is to increase the safety of all inmates in our custody by eliminating sexual assault, abuse, and harassment within our facilities.

Training

All staff members (deputy sheriffs, detentions deputies, civilian staff, and volunteers) are required to receive ongoing annual training and instruction on PREA requirements related to their specific roles and responsibilities. Training topics include:

- Methods of prevention and detection of sexual assault, abuse, and harassment;
- Investigation of reported abuse;
- Confidentiality requirements;
- Effective communication with targeted groups (lesbian, gay, bisexual, transgender and intersex (LGBTI) individuals);
- Roles and responsibilities of first responders.

Investigation

As a law enforcement agency, KCSO has always responded to and investigated crimes occurring within our facilities. Supervisory staff receives specialized training to conduct sexual abuse investigations within the confinement setting.

Screening

Screening procedures include a specific series of questions asked during the intake and transfer process to help determine if an individual is at risk of being sexually abused or being abusive

towards other inmates. The responses to these questions help classification staff to determine the best place to house each individual, and with whom. Education is provided using posters and a video that is played daily in English and Spanish. These educational materials cover KCSO's zero-tolerance policy towards sexual assault, abuse, or harassment, and how such incidents may be reported.

Counseling

PREA requires that inmates who have reported experiencing any sexual abuse in their lives are to be given contact information for a Rape Crisis Center. To further our agency's commitment to PREA and to promote healing for inmate victims of sexual abuse, KCSO contracts with a rape crisis counseling service. These counselors provide in-person counseling at all facilities to inmates who might be suffering from the trauma of sexual abuse. This service is provided by Women's Center High Desert (WCHD).

Audit History

In 2015, KCSO became one of the first California agencies to be certified as PREA compliant. After spending several years implementing the PREA standards, KCSO contracted with an auditor certified by the U.S. Department of Justice to conduct the first audit of each of its facilities. PREA audits are conducted on a triennial basis (every three years), with the first audit cycle beginning in 2013 and ending in 2015.

KCSO's certification process began in January 2015 with audits of the Central Receiving Facility (CRF), Maximum-Medium Facility, and its two substation jails in Mojave and Ridgecrest. In May 2015, the Pre-Trial and Minimum facilities began their audits.

The PREA audit process includes the auditor's review of agency policies, procedures, and practices to determine if they are in compliance with the requirements of the PREA standards. The review also seeks to ensure the agency's approach furthers the goal of preventing, detecting, and responding to sexual abuse in custody facilities.

The audit process includes a corrective action period in which the auditor and PREA team work together to revise policies or procedures if needed, or correct any identified deficiencies. This corrective action period helps ensure the agency understands any noted issues and develops a plan for correction, ultimately ensuring that best practices are in place.

KCSO continues to maintain compliance certification by contracting with a certified PREA auditor for routine auditing of its facilities. In 2019, the Maximum-Medium and Justice Facilities were audited by a certified Department of Justice PREA Auditor. These facilities were found to be 100% compliant with all standards, policies, and investigations.

KCSO looks forward to once again being a leader among California Sheriffs' agencies by remaining compliant with PREA standards to keep inmates safe from sexual assault, abuse, or harassment.

Summary of KCSO 2019 facility reports

Upon the completion of an investigation and review, each allegation was assigned one of the dispositions defined below:

- **Substantiated Allegation** - An allegation that was investigated and determined to have occurred.
- **Unfounded Allegation** - An allegation that was investigated and was determined not to have occurred.
- **Unsubstantiated Allegation** - An allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.

Central Receiving Facility

KCSO's Central Receiving Facility (CRF) 2019 report shows an increase in the number of reported sexual assault, abuse, and harassment incidents from the previous year. In 2018, there were five reported incidents and in 2019, there were ten. Of the ten allegations in 2019, there were six allegations against staff, three for inmate on inmate abuse, and one inmate-on-inmate harassment. The ten incidents reported are listed below with a brief synopsis.

For inmate privacy and confidentiality, all personal identifying information has been redacted.

Nonconsensual sexual acts - Inmates claimed to have been sexually assaulted either with force or pressure.

- **Three unfounded reports of nonconsensual sexual acts were reported:**

In one incident, the reporting inmate claimed to be raped by multiple inmates while housed in a cell alone. Video surveillance proved no other inmates were ever in the cell with the reporting inmate.

In the second incident, the reporting inmate reported to a family member that they had been raped by another inmate. The inmate denied the incident happening when the investigator attempted to interview them.

In the third incident, the inmate claimed to have passed out in their cell alone and woke up with pain to their anus, which made them believe they had been sodomized. Video surveillance was reviewed and proved that no one entered the cell during the time in question.

Sexual Harassment – Inmates stated they were told to perform a sexual act, subjected to a view of an unclothed inmate, or ongoing and unwanted verbal communication of a sexual nature.

- **One unfounded report of sexual harassment between inmates was reported:**

The reporting inmate reported to mental health staff that multiple inmates in their cell stated they were going to sexually assault the inmate due to their charges.

When the inmate learned that there was video surveillance that could verify their accusations, they refused to further report the incident. Video surveillance was reviewed and there was no evidence to verify the inmate's accusations.

Staff sexual misconduct – Inmates alleged staff inappropriately assaulted or abused them.

- Six unfounded reports of staff sexual misconduct were reported:

In one incident, the reporting inmate claimed to have been harassed during a search. Upon further investigation, the incident was determined to not meet the PREA standard reporting guidelines.

In the second incident, the reporting inmate claimed that they were being harassed by being required to perform a visual body cavity search. The search was determined to have been carried out within the law and Kern County Sheriff's Office policy.

The third incident involved an inmate stating they were touched inappropriately during a pat down search. The pat down search was conducted in an area that was monitored by video surveillance. The video was reviewed and disproved the inmate's allegations.

In the fourth incident, the inmate claimed to have been touched inappropriately during an incident. The investigator was able to review body worn camera footage from the incident and determine the inmate's accusations were unfounded.

The fifth incident involved an inmate accusing staff of assaulting them during a use of force incident. Video surveillance that recorded the incident was reviewed and the inmate's accusations were deemed to be false.

In the sixth incident, an inmate claimed to have been assaulted while being placed in the sobering cell. A body worn camera recorded the incident and was reviewed. No misconduct was found to have occurred.

The allegations against staff have been fully investigated by KCSO's Special Victims Unit (SVU) and were deemed to be unfounded based on all available evidence.

Mojave and Ridgecrest Substations

KCSO's Ridgecrest Facility did not receive any reports of sexual abuse due to them not receiving and housing inmates since June 30, 2016. The Mojave Facility received one complaint of inmate on inmate harassment. The incident reported is listed below with a brief synopsis.

For inmate privacy and confidentiality, all personal identifying information has been redacted.

Sexual Harassment – Inmates stated they were told to perform a sexual act, subjected to a view of an unclothed inmate, or ongoing and unwanted verbal communication of a sexual nature.

- One unfounded report of sexual harassment was reported:

The incident involved an inmate claiming they were sexually harassed while walking by another cell with two inmates in it. An officer was present when the alleged incident occurred. The officer did not witness any harassment take place. A review of video surveillance was conducted and verified that no harassment took place.

Lerdo Minimum

For the 2019 report year, KCSO's Minimum Facility did not house any inmates. Thus, no reports of sexual abuse were reported. Although the facility did not house any inmates, Minimum was still audited by a certified Department of Justice PREA Auditor and was certified as 100% compliant with standards for this audit.

Lerdo Maximum-Medium

KCSO's Maximum-Medium Facility showed an overall decrease in reported non-consensual sexual acts, abuse, and harassment allegations. In 2018 there were eight reported incidents, and in 2019 there was only one reported incident. The incident reported is listed below with a brief synopsis.

For inmate privacy and confidentiality, all personal identifying information has been redacted.

Nonconsensual sexual acts - Inmates claimed to have been sexually assaulted either with force or pressure.

- One unsubstantiated report of nonconsensual sexual abuse was reported:

The inmate claimed that another inmate attempted to kiss them on the mouth twice. The suspect denied the accusations and there were no other witnesses available.

Lerdo Pre-Trial

KCSO's Pre-Trial facility shows an overall decrease in reported non-consensual sexual acts, abuse, and harassment allegations from the previous year. In 2018, there were twenty-six reported incidents and in 2019 there were twenty-two. As KCSO's largest detentions facility, Pre-Trial contains both male and female housing units, a full infirmary, and an Admission, Evaluation and Stabilization (AES) center to restore individuals who have been determined to be incompetent to stand trial. The twenty-two incidents reported are listed below with a brief synopsis.

For inmate privacy and confidentiality, all personal identifying information has been redacted.

Nonconsensual sexual acts - Inmates claimed to have been sexually assaulted either with force or pressure

- Two unfounded reports of nonconsensual sexual acts were reported:

The first incident involved an inmate claiming to have been sexually assaulted by their cellmate. When questioned about the incident, the inmate was unable to provide information and admitted a sexual assault did not take place.

In the second incident, the reporting inmate claimed that an inmate entered their cell and attempted to remove the pants of the victim. Review of the video surveillance proved that no inmate ever entered the reporting inmate's cell.

- Six unsubstantiated reports of nonconsensual sexual acts were reported:

Three of the reported allegations involved inmates stating they were assaulted, but once the investigator attempted to interview them, they refused to provide them with additional details or information.

One of the reported incidents was reported to have happened the last time the inmate was in custody. The inmate claims to have been given medication by other inmates who then sexually assaulted him. Due to the elapsed time, no evidence was able to be collected, and the inmates that were still in custody could not provide information to substantiate the claim.

The fifth incident involved an inmate reporting that their cellmate had intimately kissed parts of their body. A review of video surveillance and witness questioning was unable to substantiate the inmate's claim.

The sixth incident that was reported involved an inmate claiming to have been assaulted in their cell by three other inmates with a foreign object. The inmate was transported to a local hospital and they were evaluated by a Sexual Assault Nurse Examiner (SANE). At the end of the exam, no evidence or trauma was found to exist.

Abusive sexual contact – Inmates claimed to have been touched by another inmate

- Four unsubstantiated reports of abusive sexual contact were reported. All four of the reported incidents involved inmates claiming they were touched on an intimate part of their body over their clothes. Neither witnesses nor video surveillance were able to support the abuse allegations.

Sexual Harassment – Inmates stated they were told to perform a sexual act, subjected to a view of an unclothed inmate, or ongoing and unwanted verbal communication of a sexual nature

- Two unsubstantiated reports of sexual harassment were reported:

Two inmates reported that they were receiving sexually explicit mail from another inmate and they were being harassed. The investigators were unable to prove the letters were actually coming from the alleged suspect.

The second reported incident involved an inmate having a physical altercation with their cellmate. The reporting inmate reported that the altercation was because of sexual harassment that had previously occurred during the day between the two inmates. There were no witnesses or any other evidence to substantiate the claim.

Staff sexual misconduct – Inmates alleged staff inappropriately assaulted or abused them

- Seven unfounded reports of staff sexual misconduct were reported:

The first incident involved an inmate reporting they were raped by an officer while being treated at the hospital. The inmate provided inconsistent statements during the investigation, and the description of the officer did not describe any officers assigned to guard the inmate. The inmate also claimed that the officer smoked a cigarette during the incident, and then stood in the hospital hallway and continued to smoke. Medical staff was interviewed and confirmed that no one was smoking in the halls.

The second incident involved an inmate stating another inmate entered their cell and raped them. Video surveillance was reviewed and disproved the inmate's allegations. No staff ever entered the inmate's cell as reported.

There were two separate incidents where inmates claimed to have been searched inappropriately. Video surveillance and documentation proved that the searches were done in accordance with Sheriff's Office policy.

Another incident involved an inmate stating that an officer was standing outside of their cell and using an electronic device to electronically sexually assault them. Video Surveillance was reviewed and was able to disprove the inmate's allegation.

Two separate incidents were reported stating that officers stood outside an inmate's cell and masturbated. One of the reporting inmates claimed to be able to see through walls and was able to watch the officer masturbate. Video surveillance was reviewed and disproved these allegations as well.

Staff sexual harassment – Inmates alleged that staff made verbally offensive comments towards them

- One unfounded report of staff sexual harassment involved an inmate claiming that officers called them a "punk" and they believed it to mean something of a sexually harassing nature. There was video and audio recording at the location in which the inmate claimed the harassment took place. Both recordings were reviewed and proved that the interaction with the inmate was handled professionally and without any harassing comments being made.

Lerdo Justice

In 2019, the Justice Facility was audited by a certified Department of Justice PREA Auditor. The auditor reviewed the policies, procedures, and documentation of all reported incidents. The auditor interviewed staff members of all ranks and spoke with inmates to make sure that KCSO follows its zero-tolerance policy and that all reported incidents receive a complete and thorough investigation. The Justice Facility was certified as 100% compliant with standards for this audit.

KCSO's Justice Facility report for 2019 shows an increase in reported staff sexual harassment and misconduct incidents from the previous year. In 2018, there were ten reported incidents and in 2019, there were thirteen incidents. The Justice Facility is built to modern standards with the most current technology and security features. This facility currently houses male General Population, Protective Custody, and Administratively Segregated inmates. The thirteen reported incidents are listed below with a brief synopsis.

For inmate privacy and confidentiality, all personal identifying information has been redacted.

Nonconsensual sexual acts - Inmates claimed to have been sexually assaulted either with force or pressure

- **Two unfounded nonconsensual acts were reported:**

The first report involved an inmate stating that an invisible inmate was assaulting them in their cell. They claimed to be experiencing the assault while fully clothed. There was no evidence found to substantiate the inmate's claim.

The second report involved an inmate claiming ten inmates entered the cell and sexually assaulted them. The inmate claimed after the assault occurred all the suspects were eaten. No inmates were ever witnessed on video surveillance entering the inmate's cell.

- **One unsubstantiated nonconsensual act between inmates was reported:**

The reported incident involved an inmate stating that their cellmate forced them to orally copulate them inside of the cell. There were no witnesses and the victim refused to allow a medical examination to be performed to check for any evidence.

Abusive sexual contact – Inmates claimed to have been touched by another inmate

- **Two unsubstantiated abusive sexual contact incidents were reported:**

The first incident involved an inmate stating that their old cellmate had touched their buttocks. The inmate refused to cooperate with the investigator and give any more details.

The second incident was an inmate claimed they woke up multiple times to their cellmate touching them underneath their clothes. There were no witnesses nor was there any video surveillance where the alleged abuse occurred.

Sexual Harassment – Inmates stated they were told to perform a sexual act, subjected to a view of an unclothed inmate, or ongoing and unwanted verbal communication of a sexual nature

- Two unfounded sexual harassment incidents were reported:

The first incident involved an inmate stating they were being told to masturbate when they teleported to the parole office through the sink in their cell. There was no evidence to substantiate this claim; the inmate was referred to Correctional Behavioral Health for follow-up care.

The second incident involved an inmate claiming to be the victim of witnessing indecent exposure. The alleged incident occurred in an area under video surveillance. The surveillance was reviewed and proved the incident did not occur as originally reported.

Staff sexual misconduct – Inmates alleged staff inappropriately assaulted or abused them.

- Four unfounded sexual harassment incidents were reported:

The first incident alleged that staff were engaging in sexual acts with minors, US Navy Seals, and miscellaneous other people in the housing unit. KCSO does not house minors, and the review of video surveillance disproved the allegations. The inmate had a history of mental health issues.

The second incident involved an inmate claiming that while a pat-down search was being performed on them that they were touched inappropriately. The search was performed in an area that was monitored by video surveillance, and the search was found to have been performed within the Sheriff's Office policy.

The third incident involved an inmate stating that they witnessed medical support staff touch themselves in a sexual nature while talking to a deputy. The alleged incident occurred under video surveillance. The entire interaction between the two staff was reviewed and at no time was there any touching as reported.

The last incident involved an inmate claiming to have been digitally penetrated during a medical exam. The KCSO Special Victims Unit assisted with the investigation. Video evidence was reviewed and potential witnesses were interviewed. After viewing video footage, as well as there being no physical evidence to substantiate the claim, it was found the incident did not occur.

Staff sexual harassment – Inmates alleged that staff made verbally offensive comments towards them

- Two unfounded staff sexual harassment incidents were reported:
Both incidents reported that an officer made statements that the inmates felt were sexually harassing in nature. Surveillance and audio recordings documented the interaction between the reporting inmate and deputy. The recordings proved the alleged incidents of harassment did not occur.

Conclusion

In conclusion, KCSO investigated a total of forty-seven reports in 2019, a slight decrease from the previous year. The video surveillance systems which are in place at all facilities have proven to be an excellent tool for our investigators by providing evidence to substantiate or disprove allegations, and as a deterrent of new crimes.

We are still experiencing inmates making false allegations hoping to be moved from particular housing units. There can be a multitude of reasons, but the most common seems to be that the inmates want to be housed with friends or escape debts they have incurred with other inmates in the housing units. Although these false allegations are still occurring, it should be noted that all allegations are investigated thoroughly as part of our commitment to preventing, detecting, and responding to sexual abuse and harassment in our facilities. The Kern County Sheriff's Office maintains its commitment to zero tolerance of any form of sexual abuse and sexual harassment.

The KCSO PREA Compliance team continues to look for ways to improve our PREA program through the review of policies and reported incidents, as well as input from our auditors in an effort to identify any contributing factors or areas where we can improve our procedures. We remain optimistic that continued enforcement of the PREA standards, combined with our inmate educational programs, will help us decrease or eliminate all forms of nonconsensual sexual acts, sexual abuse, and sexual harassment within our facilities.
