Lerdo Pre-Trial Facility Jail Staffing Plan 2020

The Prison Rape Elimination Act (PREA, standard 115.13, requires each facility operated by the agency to develop, document, and make its best effort to comply with, on a regular basis, a staffing plan that provides for adequate levels of staffing and video monitoring, where applicable, to protect inmates against sexual abuse.

Among the requirements set forth by PREA is that the agency operates its facilities using generally accepted detention and correctional practices. The Kern County Sheriff's Office Detentions Bureau (KCSO) is inspected every two (2) years by the California Board of State and Community Corrections (BSCC).

Housing Units

The Pre-Trial Facility is made up of seven pods with six units in each pod. The cells in each unit have two-person bunk beds. Each unit is two story with an open dayroom containing tables, chairs, a television viewing area, phones, and a drinking fountain. Each unit has a shower on the top and bottom tier. The shower areas in each unit have appropriate privacy partitions while still allowing for staff to monitor activity to ensure the adequate safety of the inmates. The cell doors remain open while the inmates have access to the dayroom, giving each inmate access to the restroom in their cell. Each unit can house 30-32 inmates. Please see table below.

The Sheriff's Aides (civilian staff) are assigned to the pod control rooms and have a general view of the activity within the housing units. The Sheriff's Aides observe all areas of the housing units via direct observation from the control room and camera monitors.

Communication between inmates and the deputies assigned to the unit is conducted in both oral and written forms (i.e. request slips and grievances). Safety and security of the area is maintained by detention deputies conducting thorough, random, unannounced checks of the housing areas. The facility corridors, infirmary, classrooms, housing dayrooms and receiving area are monitored by video monitoring in addition to deputies throughout the course of their duties.

Inmates are escorted to classrooms for educational programs and religious services. Routine medical services are provided on a daily basis. Inmates with medical concerns requiring immediate medical care are escorted to the facility infirmary or local hospital for treatment. There are two deputies assigned to the infirmary on each of the four shifts.

The infirmary is made up of suicide watch cells, medical cells, and safety cells.

Inmate Population

The Pre-Trial Facility houses male and female inmates. The classifications of the inmates are a variety of general population, protective custody, and the administratively segregated. The facility houses inmates of all races and adults of all ages. There are a variety of sub classifications and factors that can dictate classification and housing as well, such as civil inmates, inmates with physical and/or mental disabilities, gang members, assaultive, and high profile.

Inmate Programs

Inmate programs are run Monday through Friday, during the day shift. The programs are run by Sheriffs Program Specialists, staff from Kern Behavioral Health and Recovery Services, and contracted civilians. The classes are monitored by the Compliance Section, Programs Unit.

Inmate programs consist of evidence-based classes that tend to the behaviors of substance abuse addiction and violence. Bakersfield Adult School is also contracted to provide classes and G.E.D testing. Employment services are also available to the inmates.

Religious Services are offered throughout the week. The Chaplains report to the Inmate Services Section.

Staff Training

The Kern County Sheriff's Office Detentions Bureau abides by the California Code of Regulations, Title 15. All Detention Deputies attend a 12-week California Standards and Training for Corrections (STC) approved academy prior to working in the jail. All Detention Deputies receive an additional 24 hours of annual training as required through STC. All staff members, sworn and civilian, have received PREA training.

Staffing Formula

The Pre-Trial Facility ensures there are enough staff to maintain the safety and security for all inmates. The Pre-Trial Facility houses 796 inmates and it has been determined that the number of inmates dictates the staffing formula. Please see the staffing plan.

Staffing Plan

The purpose of this staffing plan is to establish basic security staffing protocols to ensure a safe and secure environment for inmates and staff.

Real time video monitoring of inmate common housing areas, holding cells and circulation areas shall provide additional inmate safety.

Staff positions identified for security operational purposes are guidelines and shall be flexible according to facility needs.

Serious incidents at other facilities may result in limited operations for varied amounts of time. Normal minimum staffing levels on night shifts shall be one less than day shift. In addition to normal minimum staffing levels, seven additional deputies are assigned administrative security duties from 7:00 am to 3:00 pm weekdays and five additional deputies are assigned to the AES program from 8:00 am to 4:00 pm weekdays.

The Pre-Trial Facility is managed by a Lieutenant. The facility also has an Administrative Sergeant assigned to a 5 day, 8-hour shift. The AES has an Administrative Sergeant assigned to a 5 day, 8-hour shift. The Lieutenant and Sergeants on both day and night shifts make regularly unscheduled and unannounced rounds throughout the facility to ensure the safety and security of the facility. The facility

operates on 12-hour shifts with day shift starting at 0700 hours and night shift beginning at 1900 hours.

Definitions:

Normal operations - Regular daily operations that occur without incident under normal procedures resulting in no staff reductions.

Limited operations - Reduction of staff or facility operations in one or more areas of the facility due to a limited or unexpected event.

Restricted operations - Critical or emergency event which halts several or all facility operations and/or significant staff reduction.

Limited event- Example: tours, inspections, training.

Unexpected event- Example: ill staff, scheduling error, hospital transportation.

Critical event- Example: death, major assault, power disruption.

Emergency event- Example: natural disaster, fire, riot, civil unrest, terrorism.

In developing the above staffing plan, the Kern County Sheriff's Office in conjunction with its Detentions Bureau and the Pre-Trial Facility manager, have considered the following factors:

- 1) Generally accepted detention and correctional practices: The Kern County Sheriff's Office continually looks at National Institute of Corrections updates and other organizations updates. Kern County Sheriff's Office is a member of the American Jail Association, and the National Sheriff's Association. We constantly network with other jails in the State of California and some jails out of state to keep up to date and seek better ways to ensure safety and security of the facility.
- 2) Any judicial findings of inadequacy: The Kern County Sheriff's Office received a judicial ruling in Yeager v Kern, 1987 requiring them to provide specific services to pregnant and post-partum inmates.

A second judicial ruling, Anderson v. Kern (1990) mandated that the Kern County Sheriff's Office does not exceed specific population totals. Additionally, the ruling mandated certain other conditions of confinement dealing with medical, staffing levels, dental, vision, and mental health care, language interpreters, access to courts, and classification of administratively segregated inmates. There are no specific judicial findings of inadequacy at the Pre-Trial Facility jail.

- 3) Any findings of inadequacy from Federal investigative agencies: The Kern County Sheriff's Office has not had any Federal investigative findings of inadequacy.
- 4) Any findings of inadequacy from internal or external oversight bodies: The Kern County Sheriff's Office participates in biannual inspections from the Bureau of State Community Corrections (BSCC) to ensure compliance with Title 15 and Title 24 regulations. It was determined during the 2018/20 inspection that the Pre-Trial Facility was non-compliant with Restraint logs. Corrective measures have been established.
- 5) All components of the facility's physical plant (including "blind-spots" or areas where staff or inmates may be isolated): Due to the age of the facility, its design features areas within the jail with blind "blind spots". Some of those areas have been secured, while others are restricted from inmate access.
- 6) The composition of the inmate population: Listed above
- 7) The number and placement of supervisory staff: In addition to the overall responsibility of Pre-Trial operations and facility administration, the Lieutenant coordinates with the five other Lerdo Complex Lieutenants and the Division Commander on issues of inmate safety, behavioral health, medical services, policy review, emergency preparedness, and public relations. The Administrative Sergeant and Senior oversee many support services, a few of which are vehicles, keys, supplies, clerical staff, public issues, criminal complaints, inmate discipline, and inspections. Security operations are staffed by a Sergeant and three Senior Deputies on each shift to oversee daily security and operational issues, respond to emergencies, and manage the schedules and overtime to ensure adequate staffing.

- 8) Institution programs occurring on a particular shift: Listed above
- 9) Any applicable State or local laws, regulations, or standards: There are no applicable State or local laws that apply to staffing in a county jail. State Regulations under Title 15 of the Board of State Community Corrections require adequate staffing to ensure inmate safety.
- 10) The prevalence of substantiated and unsubstantiated incidents of sexual abuse: Listed above
- 11) Any other relevant factors: There are no other relevant factors at the Pre-Trial Facility that affect its ability to detect, prevent, and respond to issues of sexual abuse, assault, or harassment of inmates in its care and custody.

For facility security, staffing numbers have been redacted from this report.
