Based upon a review of your criminal history record and submitted supporting documentation, the California Department of Justice will determine whether you meet the requirements for exclusion from disclosure on the Megan's Law Internet Web Site.

**Notice to Registered Sex Offenders  
Eligibility For Exclusion from Internet Web Site**

You are eligible to apply for exclusion from the Megan's Law Internet Web Site if all of the following conditions apply:

1. You were convicted of one or more of the following:
  - A felony violation of Penal Code (PC) section 243.4, Subdivision (a) – Sexual Battery;
  - A misdemeanor violation of Section 647.6 PC (former section 647a) – Annoy or molest child; or
  - A Section 290 PC offense for which you successfully completed probation or are currently on probation.
2. You have never been adjudicated a sexually violent predator pursuant to Welfare and Institutions Code 6600, et seq.
3. During the period of probation, you neither received additional incarceration time for a violation of probation nor were not convicted of another offense resulting in a sentence to county jail or state prison.

If, subsequent to your application, you violate probation resulting in state prison or additional county jail time, your exclusion or application for exclusion, from the Internet Web Site shall be terminated.
