IMARF ORDERS

It has become common for inmates to refuse to be transported to court for their scheduled hearings. The resolution to this problem has been clarified by Presiding Judge Humphrey. An IMARF is an order documented in an in-custody defendant's court documents that authorizes the Sheriff's Office to use reasonable force to send/take a defendant to court.

Presiding Judge Humphrey clarified that this order was intended for the next court date after the IMARF was issued. Unless otherwise stated, this is a one-time order. If there is a situation where a defendant is needed for multiple or consecutive court appearances, there will be a specific order authorizing force to be used to transport a defendant through the court process, where it is determined they are needed.

If there is a situation where a supervisor expects a violent altercation, which may result in an injury of the inmate or a staff member, the force order shall not be imposed. The judge making the force order will be contacted and advised of the situation. The judge will choose to either revise or reaffirm the order. Once that determination has been made, staff will proceed and impose the updated order from the judge.
